Small Sized Dogs: ¼ to ½ teaspoon added to food or as directed by your veterinarian.

Med Sized Dogs: ½ to 1 teaspoon added to food or as directed by your veterinarian.

Large Size Dogs: 1 -2 teaspoons added to food or as directed by your veterinarian.

1 tablespoon = approximately 9g- 1 teaspoon= approximately 3g
